### MARKET OVERVIEW

#### Pre Open Thoughts: Time Changes Everything!!

Time changes everything except something within us which is always surprised by change. It is rightly said you can never plan the future by the past. May month has drawn to close and thankfully the last Friday of this month, the Famous adage "Sell in May and Go Away" doesn't work now as from last three years May has given positive returns.

From rollovers into June Series which were seen at 73% against 3 MAV of 68% and a tad lower than last month's 74% (in line with value of last month's 164.5 bn).

As mentioned in my last note Nifty has crossed 8000 convincingly to bolster investor confidence it can hit a highs of 8150/8200 levels in coming month Going forward June series is likely to see continued Buying momentum which can take the Nifty to 8336 with immediate effect.

Volatility may remain at elevated levels and a sharp selloff post this on back of rising IV, HV may lead to Nifty retesting 7700-7800 lows once.

In some stock Picks: given the long roll/short covering status in most of our near term Reco, were initiate Buy on Dips for L&T, Axisbank, Tatamotors, Ultracemco and Heromotoco. High beta Cyclicals like Adaniports, Hindalco and SBI are expected to run up close to 10% as well.

In non-index names, NBFCs appear amongst the best poised for high momentum long trades including Lichsg, Srtransfin. Exideind, Abirlanuvo, Relinfra and Indiacem are amongst high conviction Long ideas for 12% upside targets.

We however believe the Nifty is strongly poised for a mega bull run over the next 12-15 months, and Dips till 7700/7500 could be used to aggressively long Cyclicals mentioned above.

### **IMPORTANT MARKET HIGHLIGHTS**

Prime Minister Narendra Modi's comments in an interview to a foreign newspaper that he had undertaken the maximum reforms during the past two years in office and that he expects the goods and services tax (GST) bill to pass this year triggered the latest rally on the domestic bourses. Modi said he had opened up more of the economy to foreign investment and made changes to curb corruption, fill gaps in rural infrastructure and make it easier to do business. He also said that he has an enormous task ahead.

The Sensex hit its highest level in almost 29 weeks when it jumped 517.77 points, or 2% at the day's high of 26,398.94 in late trade. The index rose 60.34 points, or 0.23% at the day's low of 25,941.51 in early trade. The Nifty hit its highest level in more than 29 weeks when it jumped 148.10 points, or 1.87% at the day's high of 8,083 in late trade. The index rose 13.60 points, or 0.17% at the day's low of 7,948.50 in early trade.

State-run ONGC rose 2.05% to Rs 214.50 after net profit rose 12.22% to Rs 4416.11 crore on 15.42% decline in total income to Rs 19776.70 crore in Q4 March 2016 over Q4 March 2015. The result was announced at the fag end of the trading session today, 26 May 2016.

Tata Steel rose 0.83% at Rs 327.05 after the company trimmed losses in Q4 March 2016. The company reported consolidated net loss of Rs 3213.76 crore in Q4 March 2016, lower than net loss of Rs 5674.29 crore in Q4 March 2015. Tata Steel's total income fell 12.33% to Rs 29636.69 crore in Q4 March 2016
